#### RESPONSIBILITIES OF SKIERS & ACKNOWLEDGMENT OF RISK

In consideration of being permitted to use the facilities at Holiday Valley Resort in Ellicottville, New York, I expressly acknowledge:

1. I have read and understand "Your Responsibility Code Under the New York Safety in Skiing Code" (12 N.Y.C.R.R., Part 54.5) and the "Season Pass Policy" and the "State Safety Skiing Code" (Article 18, of the N.Y.S. General Obligations Law) and agree to be bound by them.
2. I am physically fit and possess the physical strength to meet my responsibilities as a skier, and state that I will not participate in the sport of skiing while under the influence of drugs or alcohol.
3. I agree to observe, read, and abide by any and all notices as may be posted from time to time by Holiday Valley Resort which may pertain to my responsibilities as a skier;
4. I grant permission to Holiday Valley Resort to utilize any photograph, videotape, motion picture, recording or other record of my use of its facilities for any legitimate purpose;
5. I acknowledge that trail conditions vary constantly because of weather changes and skier use. I also understand that ice, variations in terrain, moguls, rocks, forest growth, debris, as well as other natural or man made objects which are incidental to the sport of skiing, including vehicles and other skiers, exist throughout the area. I further understand that there may be snowmaking and/or grooming in progress necessitating further equipment and vehicles on the slopes and trails. I therefore acknowledge that there are risks inherent in the sport of skiing, and that as a participant, I could suffer personal injuries and/or death.
6. My signature on the front signifies that I have read, reviewed and understand the "Warning to Skiers" posted at this ski area. I agree that this acknowledgment shall be for the entire term of the pass and I relinquish my right to a refund of the purchase price of the pass that is allowable under "Safety in Skiing Code" for those persons unwilling to ski because of the sport or the duties imposed upon skiers by law.

#### ATTENTION SKIERS ... PLEASE READ CAREFULLY

1. Programs begin Nov. 25, 2011. Night lessons conclude Mar. 9, 2012 (night skiing ends Mar. 17 2012 (weather permitting).
2. White Card, Flexi Night, Sunday Xpress and Pick-A-Night programs receive one bonus day redeemable any day or night of the week in Mar. or Apr. Rental equipment not included.
3. On Dec. 26, 2011 - Dec. 30, 2011 the White Card & 50/50 card is valid starting at 4PM. Sunday Xpress and 50/50 Card is valid, Jan. 15, 2012, Feb. 19, 2012 starting at 2:30 PM.
4. All ticket sales are final. NO REFUNDS after Dec. 1, 2011. Programs are nontransferable and cannot be used by another skier. Use by another skier will void the card. Unused programs cannot be transferred to the following season.
5. Upon completing the White Card, Flexi Night Card, Sunday Xpress Pass, and 50/50 card skiers are entitled to a \$5 discount on lift tickets of the same type for themselves only. Discount valid on current ticket price and cannot be used in conjunction with other discounts or promotions.
6. Management reserves the privilege to operate slopes, trails and lifts at their discretion based on snow conditions and daily skier visits. Season opening and closing dates are subject to change based on snow conditions and daily skier visits.
7. Programs only valid for ages 8 yrs. and up as of Nov. 1, 2011.

**YOUR RESPONSIBILITY CODE.** Know the Code. It's Your Responsibility. Skiing can be enjoyed in many ways. At ski areas you may see people using alpine, snowboard, telemark, cross country or other specialized ski equipment, such as that used by disabled or other skiers. Regardless of how you decide to enjoy the slopes, always show courtesy to others and be aware that there are elements of risk in skiing that common sense and personal awareness can help reduce.
