### RESPONSIBILITIES OF SKIERS & ACKNOWLEDGEMENT OF RISK

In consideration of me or my child being permitted to use the facilities at Holiday Valley Resort in Ellicottville, New York, I expressly acknowledge: I have read and understand the "Safety in Skiing Code" (Article 18 of the N.Y.S. General Obligation Law), the "Responsibilities of Skiers and Passengers" (12 N.Y.C.R.R., Part 54.4) and Holiday Valley's "Season Pass Policy" and agree to be bound by them. I have read and explained those regulations and responsibilities to my child in an age appropriate manner and he/she has acknowledged that he/she understands and agrees to be bound by them. Article 18 is posted at all ticket sale locations and at [www.holidayvalley.com](http://www.holidayvalley.com). I and my child are physically fit and possess the physical strength to meet our responsibilities as a skier/rider, and state that we will not ski or ride while under the influence of drugs or alcohol. I and my child agree to observe, read and abide by any and all notices as may be posted from time to time by the Resort which may pertain to our responsibilities as a skier/rider. I grant permission to the Resort to use any photograph, videotape, motion picture, recording or other record of my or my child's use of its facilities for any legitimate purpose. I and my child understand that trail conditions vary constantly because of weather changes and skier use. I and my child also understand that the risks of skiing/riding also include terrain park elements, jumps, slide rails and other man made features, changing weather conditions, bare spots, variations in snow, ice, forest growth, other ground cover, surface and subsurface conditions, and terrain, bumps, moguls, rocks, debris, equipment and machinery on slopes, collisions with other skiers and snowboarders, and natural and man made objects, and skier/snowboarder error. I have explained these risks to my child in an age appropriate manner. I and my child acknowledge that there are risks inherent in the sport of skiing/riding, and that as participants, I and my child could suffer personal injuries and/or death. I and my child accept the risks of personal injury and/or death. My signature below signifies that I and my child have read, reviewed and understand the "Warning to Skiers" posted at this ski area. I agree, on behalf of myself and my child, that this acknowledgment shall be for the entire term of the pass and I relinquish my right to a refund of the purchase price of the pass that is allowable under "Safety in Skiing Code" for those persons unwilling to ski because of the sport or the duties imposed upon skiers by law. I agree, on behalf of myself and my child, that New York law applies to any issue relating to this agreement and my or my child's use of the facilities at Holiday Valley Resort. I agree, on behalf of myself and my child, that any lawsuit relating to this agreement or my or my child's use of the facilities at Holiday Valley Resort shall be brought only in the New York State Supreme Court, County of Cattaraugus, or the United States District Court, Western District of New York, and that those courts shall have sole and exclusive jurisdiction over any lawsuit relating to this agreement or my or my child's use of the facilities at Holiday Valley Resort.

### ATTENTION SKIERS and RIDERS ...

Ultimate Pass Information. Please Read Carefully

1. White Pass, Flex, Sunday and Select programs receive one free 8 hour lift ticket redeemable any day or night of the week in March or April. Rental equipment not included.
2. From Dec. 26, 2020 through Jan. 1, 2021 the White Pass is valid starting at 3:30PM. The Ultimate Sunday is valid Dec. 27, 2020, Jan. 17, 2021, Feb. 14, 2021 starting at 2:30PM. Upgrade for \$35 to ski all day.
3. All program sales are final. NO REFUNDS after Dec. 1, 2020. Programs are nontransferable and cannot be used by another skier. Use by another skier will void the card. Unused programs cannot be transferred to the following season. One lift ticket is issued per day, per skier.
4. Additional Lift ticket discounts and add ons are available upon completing the White Pass, and Flex Pass. Discount valid on current ticket price and cannot be used in conjunction with other discounts or promotions.
5. Management reserves the privilege to operate slopes, trails and lifts at their discretion based on snow conditions and daily skier visits. Season opening and closing dates are subject to change based on snow conditions and daily skier visits.
6. Group lessons included in the Select, Flex and White Pass are for ages 8 yrs. and up as of Nov. 1, 2020. Group lesson available for age 7 and up every Sunday at 3:30PM.
7. Read, complete and sign the registration form for each program purchased. If skiers/riders are under the age of 18, the form must be signed by the parent or guardian. Rental forms must also be completed and signed.
8. New program cards are mailed to individual skiers each year. The card enables skiers to receive one lift ticket per day at any ticket window.
9. Lost or stolen cards must be reported to Customer Service. There will be a \$20 replacement fee for lost or stolen cards.
